How much does Andorra export?

The total value of imports (CIF) was 1,495 million. At the HS6 digit level, 1,110 products were exported to 117 countries and 3,085 products were imported from 140 countries. Andorra exports to Spain worth US\$ 121 million, with a partner share of 72.51 percent. Andorra exports to France worth US\$ 17 million, with a partner share of 10.39 percent.

How much tax does a ship from Andorra charge?

Shipments to Spain from Andorra are subject to a 21%tax (corresponding to VAT) calculated in the DUA. If an Andorran company provides services to a Spanish company, the Andorran General Indirect Tax (IGI) should not be included in the invoices, as it is a national tax.

Are agricultural products taxable in Andorra?

Agricultural products imported into Andorra (products 1 to 24 of the Harmonised System) are not covered by the 1990 Customs Union Agreement with the EU, but are still subject to customs duties, in the form of the Consumption Tax. This is payable by individuals, companies and travellers importing agricultural products into Andorra.

Who pays the import tax in Andorra?

This tax is payable by companiesimporting products, as well as by individuals or travellers bringing industrial products into Andorra from a country outside the European Union. It applies to products 25 to 97 of the harmonised system and is paid when these products enter Andorra.

How do I export goods from Andorra to Spain?

To export goods from Andorra to Spain, you must include a tax-free commercial invoice and fill in the Single Administrative Document (DUA), which allows you to calculate the applicable tax and will be processed by Spanish customs. Shipments to Spain from Andorra are subject to a 21% tax (corresponding to VAT) calculated in the DUA.
