

Does India impose anti-dumping duties on solar glass?

The Indian Ministry of Finance has issued a notification imposing provisional anti-dumping dutieson textured, tempered, coated, and uncoated solar glass imported from China and Vietnam.

Are dumped solar glass imports undercutting the prices of the domestic industry?

The dumped imports are undercutting the prices of the domestic industryand have had a 'suppressing effect' on the prices of the domestic industry. During the POI,out of 795,555 metric tons (MT) of total solar glass imports in India,China alone shipped 659,732 MT,while Vietnam sent in 119,285 MT.

Why do IPPs have to pay anti-dumping duty on solar glass?

In this case,IPPs may invoke this clause to recover the additional costs caused by the anti-dumping duty on solar glass, as it was an unforeseen regulatory change. This would allow them to pass on the increased costs to buyers or adjust tariffs, ensuring the financial viability of their solar power projects.
