

What is energy storage Ireland?

What is Ireland's energy storage policy?

This is the first electricity storage policy published in Ireland. The Irish Government's Climate Action Plan 2021 set out the need for an energy storage policy for Ireland to support 75% reduction in power sector CO2 emissions by 2030.

How can a battery energy storage system improve Ireland's power grid?

When the demand for electricity is high, the stored energy from a battery energy storage system can be released into the grid to help meet the demand. This can contribute towards reducing Ireland's reliance on fossil fuels and improving the stability of the power grid.

Will Ireland need more energy storage?

With a target of 80% renewable electricity from intermittent sources on our grid by 2030, Ireland will require a significant amount of energy storage in the years to come.

Could new energy storage solutions be the future of Ireland?

Significant research and development is ongoing across the world on the development of new energy storage solutions and they could prove an ideal solution for the all-island Irish market, improving energy sustainability and security, while also facilitating achievement of long-term decarbonisation goals.

Are gas-turbines a threat to energy security in Ireland?

In the absence of renewable storage options,gas-turbines currently supply most of Ireland's dispatchable power generation capacity,though the lack of gas storage facilities on the island is a considerable concernwith regards to energy security.

Section 17 FA 2018 makes reference to the Sustainable Energy Authority of Ireland (SEAI) being allowed to establish and maintain a list of energy-efficient equipment under the scheme. In summary, in order for energy equipment to qualify for the accelerated capital allowances, it must appear on the SEAI list.

The Accelerated Capital Allowance (ACA) is a tax incentive scheme that promotes investment in energy efficient products and equipment. The ACA is based on the long-standing "Wear and Tear Allowance" for investment in capital plant and machinery, whereby capital depreciation can be compensated through a reduction in an organisation"s tax liability.
