What information should be included in a battery label?

All batteries must include general information on their category, chemistry, and whether they are rechargeable. All batteries containing more than 0.002% Cd or 0.004% Pb must be marked with the chemical symbol for the metal concerned. The manual recommends compliance with the U.S. Battery Act of 1996 requirement to include a Ni-Cd or Pb label.

Why do I need a battery label?

Understanding and complying with battery labeling requirements is essential, not just for legal reasons, but for safetyas well. By guaranteeing our labels meet the necessary standards, we can promote safe usage and effectively communicate important information.

Tool/Battery - Do not include more than on (1) tool kit per box. Each battery must be in a sealed bag or the

Mark All Associated Tools and Batteries. With your color code system mapped out, systematically label all tools and batteries accordingly: Wrap red electrical tape on Milwaukee M18 batteries. Put red circular stickers on the Milwaukee circular saw. Mark the Dewalt drill with yellow tape. Use green zip ties on generic 18V batteries
